## Chamberlayne Road Lay-by - Outside Kensal Rise Station

As part of the London Bus Priority Network (LBPN) programme to tackle congestion and to make bus journey times more efficient throughout the borough, the council constantly monitors bus routes and makes improvements if necessary.

Currently, bus routes 6, 28, 52, N52, 187, 302 and 452 use Chamberlayne Road. The area is served by Kensal Rise Silverlink Railway Station and these routes operate and use Station Terrace bus stops and stands.

The majority of frontages on Station Terrace are retail premises. Buses are frequently delayed by vehicles parked in the area and by vehicles that are legally permitted to load and unload. The existing bus stop and stand arrangement do not meet the need for current volume of buses in the area. Bus Nos. 28, 302 and 452 travel through a lengthy route along Dagmar Gardens/Linden Avenue and stop at the southern arm of Station Terrace. It has become necessary to reduce congestion currently being caused in this area.

A study has been carried out to review the existing bus stop and stand arrangements to ensure the smooth running of the above services. To improve the capacity of bus rail interchange at Kensal Rise and to meet the increased number of buses, a new northbound bus stop on Chamberlayne Road is proposed.

The proposed improvements are to:

- Provide a new recessed bus lay-by northbound on Chamberlayne Road
- improved accessibility for disabled)
